The Electricity (Licence fees) (Amendment) (No. 3) Regulations, 2014.

(Under Sections 10 (c), 10 (n) and 119 of the Electricity Act, Cap.145)

IN EXERCISE of the powers conferred upon the Electricity Regulatory Authority by Sections 10 (c), 10 (n) and 119 of the Electricity Act, Cap. 145, these Regulations are made this 2nd day of December, 2014.

1. Title.

This Regulations may be cited as the Electricity (Licence fees) (Amendment) (No. 3) Regulations, 2014.

2. Amendment of SI. No. 20 of 2003.

The Electricity (Licence Fees) Regulations, 2003, SI. No. 20 of 2003 in these Regulations referred to as the principal regulations are amended by substituting for regulation 2 the following—

“2. Licence and Permit fees.

(1) The annual fees payable by a licensee shall be as prescribed under parts A, B and C set out in the Schedule to these Regulations.

(2) The fees payable by an applicant in respect of an application to the Authority for a licence or permit shall be as prescribed under part D set out in the Schedule to these Regulations.

(3) The applicant under this regulation shall upon submission of the application form, pay a non-refundable fee as prescribed under part D set out in the Schedule to these Regulations.

(4) A licensee shall pay the annual fees prescribed under parts A, B and C set out in the Schedule to these Regulations not later than fourteen days from the commencement of the licence year.

(5) A person who contravenes sub regulation (3) commits an offence and is liable on conviction to a fine not exceeding two hundred currency points and in the case of a continuing offence, an additional fine not exceeding five currency points in respect of each day on which the offence continues.

(6) Where the prescribed fee is not paid within the time specified in these Regulations, a surcharge will be payable on the amount due at the rate of 1% per week up to a maximum period of twelve weeks (12).

(7) The application for the grant of a licence or permit under sub-regulation (6) shall lapse upon the expiration of the twelve weeks (12).”

3. Amendment of the Schedule to the principal regulations.

The principal regulations are amended by substituting for the Schedule the following—
