**The Local Governments (Declaration of Municipalities) Regulations, 2015.**

*(Under section 7(2a) of the Local Governments Act, cap. 243)*

IN EXERCISE of the powers conferred upon the Minister responsible for local governments by sections 7(2a) and 175(1) of the Local Governments Act, in consultation with the districts and with the approval of Parliament, these regulations are made this 9th day of September, 2015.

**1. Title.**

These Regulations may be cited as the Local Governments (Declaration of Municipalities) Regulations, 2015.

**2. Declaration of Municipalities.**

The following areas are declared to be Municipalities—

**1) Financial Year 2015/16 (Effective 1st July, 2015)**

- (a) Nansana - consisting of Nansana Division, Nabweru Division, Gombe Division and Busukuma Division in Wakiso District;
- (b) Kira - consisting of Kira Division, Namugongo Division and Bweyogerere Division in Wakiso District;
- (c) Makindye Ssabagabo - consisting of Masajja Division, Bunamwaya Division and Ndejje Division in Wakiso District;
- (d) Kisoro - consisting of Central Division, Northern Division; and Southern Division in Kisoro District;
- (e) Mityana - consisting of Central Division, Ttamu Division and Busimbi Division in Mityana District;

- (f) Kitgum - consisting of Pager Division, Central Division and Pandwong Division in Kitgum District;
- (g) Koboko - consisting of North Division, South Division and West Division in Koboko District;
- (h) Mubende - consisting of East Division, South Division and West Division in Mubende District;
- (i) Kumi - consisting of South Division and North Division in Kumi District;
- (j) Lugazi - consisting of Central Division, Kawolo Division and Najjembe Division in Buikwe District;
- (k) Kamuli - consisting of South Division and North Division in Kamuli District;
- (l) Kapchorwa - consisting of East Division, Central Division and West Division in Kapchorwa District.

**2) Financial Year 2016/2017 (Effective 1st July, 2016)**

- (m) Ibanda - consisting of Bufunda Division, Kagongo Division and Bisheshe Division in Ibanda District;
- (n) Njeru - consisting of Njeru Division, Nyenga Division and Wakisi Division in Buikwe District;
- (o) Apac - consisting of Agulu Division, Akere Division, Arocha Division and Atik Division in Apac District;
- (p) Nebbi - consisting of Thata Division, Central Division and Abindu Division in Nebbi District;
- (q) Bugirii - consisting of Eastern Division and Western Division in Bugiri District;
- (r) Sheema - consisting of Kagango Division, Kabwohe Division, Kashozi Division and Sheema Central Division in Sheema District; and
- (s) Kotido - consisting of North Division, South Division, Central Division and West Division in Kotido District.
