**The Local Governments (Declaration of Towns) Regulations, 2015.**

*(Under sections 7(3) and 175(1) of the Local Governments Act, Cap. 243)*

IN EXERCISE of the powers conferred upon the Minister responsible for local governments by sections 7(3) and 175(1) of the Local Governments Act, in consultation with the districts and with the approval of Cabinet, these Regulations are made this 29th day of June, 2015.

**1. Title.**

These Regulations may be cited as the Local Governments (Declaration of Towns) Regulations, 2015.

**2. Declaration of Towns.**

The following areas are declared to be towns—

**1) Financial Year 2016/17 (Effective 1st July, 2016)**

- (a) Kajjansi - consisting of Kajjansi Town Board in Wakiso District;
- (b) Makindye-Sabagabo - consisting of Makindye –Sabagabo Sub-County in Wakiso District;
- (c) Kyamukube - consisting of Nsuura, Mutumba and Mitandi Parishes in Kabarole District;
- (d) Kyengeru - consisting of the entire Nsangi Sub-county in Wakiso District;
- (e) Kakindo - consisting of Kyangundu, Kyangyenye, Rweibare and Ryenjoki Cells in Sheema District;
- (f) Shuuku - consisting of Kishyabya (including cells of Kirundo, Nyakabare and Rwamunena from  
Rugarama Sub-County), Kyempitsi East, Kyempitsi West and Rwabuza Parishes

- (g) Kyansi - (wards) in Sheema District;  
- consisting of Ssisa Sub-County in Wakiso District;
- (h) Katabi - consisting of Katabi Sub-County in Wakiso District;
- (i) Kyamuhunga - consisting of Kyamuhunga and Mashonga Town Boards in Bushenyi District;
- (j) Kasangati - consisting of Nangabo Sub-County in Wakiso District;
- (k) Mugusu - consisting of Kiboha and Burungu Parishes; and Kiraro and Butinda Villages in Kabarole District;
- (l) Kisinga - consisting of Kisinga Town Board in Kasese District.
- (m) Kahunge - consisting of Kahunge Town Board in Kamwenge District.
- (n) Kagarama - consisting of Kagarama Central Ward (former Kagarama Town Board), Kagamba Ward (former Kagamba Parish) and Rutunguru Ward (former Rutunguru Parish) in Ntungamo District.

**2) Financial Year 2017/2018 (Effective 1st July, 2017)**

- (o) Kisiita - consisting of Central, Nyabirungi, Bwikaragye and Kyabaliitwa Parishes in Kibaale District;
- (p) Kitagata Sheema - consisting of Kitagata Town Board in District;
- (q) Masheruka - consisting of Mabare, Kanyeganyegye, Nyakambu, Kabutsye and Buringo Parishes in Sheema District;
- (r) Kaproron - consisting of Kaproron Town Board (formerly Kamwam Parish) in Kween District;
- (s) Mabaale - consisting of Namyaka, Kyetera, Katonzi and Kyeya Parishes (wards) in Kibaale District;
- (t) Rwenkobwa - consisting of Rwenkobwa Parish in Ibanda District;
- (u) Kasanje - consisting of Kasanje Sub-County in Wakiso District;

- (v) Buyaga - consisting of Buyaga Town Board in Bulambuli District;
- (w) Magale - consisting of Magale Town Board in Manafwa District;
- (x) Kashenyi-Kajani - consisting of Kashenyi-Kajani Town Board in Buhweju District;
- (y) Buhimba - consisting of Buhimba Town Board in Hoima District;
- (z) Kasambya - consisting of Kirume, Kasambya, Nakasaga, Lubona and Kisizire Parishes in Mubende District;
- (aa) Rugendabara-Kikongo - consisting of Rugendabara-Kikongo Town Board in Kasese District;
- (bb) Kinyamaseke - consisting of Kinyamaseke Town Board in Kasese District;
- (cc) Rwentuha - consisting of Rwentuha Town Board in Bushenyi District;
- (dd) Nkoma-Katalyeba - consisting of Nkoma-Katalyeba Town Board in Kamwenge District;
- (ee) Kyamutunzi - consisting of Kyamutunzi Parish in Kyenjojo District;
- (ff) Nyamunuka - consisting of Nyamunuka Central Ward (former Nyamunuka Town Board), Kyaruhuga Parish (former Kyaruhuga Parish), Kakiika Ward (former Kakiika Parish), Kyabashenyi Ward (former Kyabashenyi Parish) and Iterero Ward (former Iterero Parish);

### **3) Financial Year 2018/2019 (Effective 1st July, 2018)**

- (gg) Kiru - consisting of Oyaro, Kalakala and Kiru Parishes (Wards) in Abim District. Abim Town Council will remain with the parishes of Angwee, Wiawer, Oringowelo and Agwata;
- (hh) Kiyindi - consisting of Kiyindi Parish with the villages of Kidokolo LC1 and Buyomba LC1 from Gulama Parish in Buikwe District;

- (ii) Ibanda-Kyanya - consisting of Ibanda-Kyanya Town Board in Kasese District;
  - (jj) Nankoma - consisting of Nankoma Town Board in Bugiri District;
  - (kk) Namayemba - consisting of Namayemba Town Board in Bugiri District;
  - (ll) Kabujogera - consisting of Kabujogera Town Board in Kamwenge District;
  - (mm) Nabingola - consisting of Nabingola Town Board in Mubende District;
  - (nn) Rugombe - consisting of Rugombe Town Board in Kyenjojo District;
  - (oo) Lwampanga - consisting of Lwampanga Town Board in Nakasongola District;
  - (pp) Mayirikiti - consisting of Mayirikiti Town Board in Nakasongola District;
  - (qq) Bukuya - consisting of Bukuya Town Board, two villages of Nabutiti and Bukonyogo from Kabosi Parish and the villages of Kamondo, Nkokonjeru and Ncwamazzi from Ncwamazzi Parish in Mubende District;
  - (rr) Kassanda - consisting of Kassanda Town Board Kitongo Parish and the villages of Kisenyi, Mirembe Maria, Bwakaggo, Namiringa, Jjemba A and Jjemba B from Namiringa Parish in Mubende District;
  - (ss) Kiganda - consisting of Kawungeera Parish, the villages of Kabalungi, Nsozinga A, Nsonziga B, Nabakazi and Kyamwero from Nsozinga Parish, the village of Kamusu and Kalamba from Kayunga-Lubona Parish; the village of Kijjomanyi-Nakiduduma from Kyojjomanyi Parish
- and
- the village of Kasambya-Kisolozza from Kasambya Parish.
