**The Registration of Persons (Fees) Regulations, 2016.**

*(Under sections 7(b) and 85(2) (i) of the Registration of Persons Act, 2015, Act No. 4 of 2015)*

IN EXERCISE of the powers conferred upon the Minister by section 85 of the Registration of Persons Act, 2015, these Regulations are made this 27th. day of January, 2016.

**1. Title and commencement.**

(1) These Regulations may be cited as the Registration of Persons (Fees) Regulations, 2016.

(2) These Regulations shall be deemed to have come into force on the 1st day of January, 2016.

**2. Fees.**

The fees specified in the Schedule to these Regulations shall be payable to the National Identification and Registration Authority in respect of the matters to which they relate under the Act and the Regulations specified in the Schedule.

**3. Revocation of SI No. 71 of 2015.**

The Registration of Persons (Fees) Instrument, 2015, S.I No. 71 of 2015 is revoked.
